Assisted Suicide: Scottish Parliament

The Bill is being examined by a Committee and then could be up for the final, Stage 3, vote in December. Working with our friends at the Catholic Parliamentary Office, I have a target list of MSPs and will be writing to individuals in these constituencies. This month, the Assisted Dying Bill's House of Lords Select Committee has faced fierce criticism for excluding public evidence and rushing scrutiny. Witnesses have exposed deep palliative care

cuts, unreliable six-month prognoses, and weak safeguards against coercion—especially for disabled and mentally ill patients. Experts warned of eligibility creep, eroded trust in healthcare, and risks to vulnerable groups amid hospice closures. With 42 ministerial powers and no impact assessments, pro-lifers are urging the Lords to shelve the flawed bill in order to prioritise quality end-of-life care over a lethal "choice" that could expand like Canada's.
